Newsom Releases May Budget Revision - \$11 Billion for Transportation

Each May, the Governor issues what is referred to as the *May Revise* for the upcoming fiscal year's budget. The budget revision takes into consideration updated funding projections, new funding opportunities, and updated needs assessments.

Based largely on a \$75 billion surplus from tax revenue, and \$27 billion in federal stimulus money, the May Revision proposes investing an additional \$11 billion in the transportation system and related zero-emission vehicle (ZEV) efforts. The transportation infrastructure package includes: roadway fix-it-first projects, High-Speed Rail and other rail, transit and active transportation projects throughout the state, enhanced safety projects, and projects to support connectivity in advance of the 2028 Los Angeles Olympics. Here are the larger pieces of the proposal:

- Los Angeles Olympics - \$1 billion General Fund to deliver critical projects in time for the 2028 Olympic Games.
- Priority Transit and Rail Projects - \$1 billion General Fund for transit and rail projects statewide that improve rail and transit connectivity between state and regional/ local services.
- Active Transportation - \$500 million General Fund to advance projects that increase the proportion of trips accomplished by walking and biking, increase the safety and mobility of non-motorized users, advance efforts of regional agencies to achieve greenhouse gas reduction

goals, enhance public health, and benefit many types of users, especially in disadvantaged communities.

- High Priority Grade Separations and Grade Crossing Improvements - \$500 million General Fund to support critical safety improvements throughout the state.
- High-Speed Rail - \$4.2 billion to help the financially troubled high-speed rail construction in the Central Valley.
- State Highway Rehabilitation and Local Roads and Bridges - \$2 billion (\$1.1 billion special funds through 2028, and \$968 million federal funds) to support the advancement of priority State Highway Operation and Protection Program (SHOPP) projects, Interregional Transportation Improvement Program (ITIP) projects, and local road and bridge investments.
- Zero-Emission Rail and Transit Equipment Purchases and Infrastructure - \$407 million (\$100 million General Fund, \$280 million Public Transportation Account, and \$27 million federal funds).
- Zero-Emission Buses and Trucks - \$1.4 billion (\$1.3 billion General Fund, \$87 million Air Pollution Control Fund).

The May Revision also includes the new Clean California Initiative in which Caltrans will partner with local governments in a statewide beautification effort. One-time funding of \$1.5 billion General Fund will be used for a three-year effort to clean up garbage statewide, beautify the state's highway system as trash build up is at the point of creating harmful effects for nearby residents and the environment.

According to the budget document, "thousands of jobs will be created through this initiative in state and local government, as well as the private sector and will provide lasting benefits to communities-especially underserved communities."

The budget does not specify which road and bridge projects could get priority. It says the state plans to "accelerate vital safety projects and important 'fix-it-first' projects on state highways and bridges."

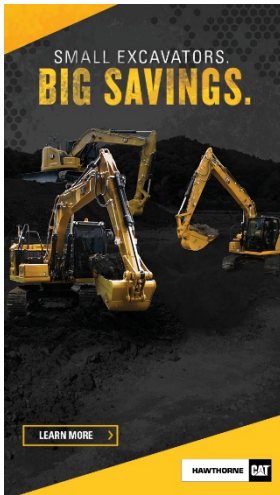
About 6% of the state's 25,763 bridges, or 1,536, are considered "structurally deficient," says a report earlier this year by the nonpartisan American Road & Transportation Builders Association. Among the local findings, according to the Federal Highway Administration's [2020 National Bridge Survey](#):

San Diego County has two of the structurally deficient bridges that are included in a list of "most travelled structurally deficient bridges," those two are:

Despite having the nation's highest motor fuel taxes and working with an ambitious 2017 state program to repair and replace damaged roads, California roads and bridges still need lots of financial help. The state is projected to face a \$6.1 billion annual shortfall, compared to expected funding needs. That assessment was part of a [287-page draft report](#), "The State Highway System Management Plan," prepared by the state transportation department for the California Transportation Commission.

State funding sources include 50.5 cents a gallon state tax, plus a federal tax of 18.3 cents a gallon. Those taxes, plus other fees motorists pay, put the levy paid on a gallon of gasoline in California at 81.45 cents a gallon, the nation's highest such tax as of January 1, said the American Petroleum Institute.

Of course the Governor's budget proposal is just that and must be ratified by the Legislature.

A Productive and Informative AGC Legislative Day

It was a first for AGC San Diego and AGC California's Annual Legislative Day... a virtual 90-minute meeting due to the restrictions of COVID-19. However, it was a very productive meeting, one which included an overview of the current legislative picture in Sacramento, eight advocacy breakout sessions with various legislators, and an informative talk by a long-time political consultant.

Over 100 AGC members, throughout the state, participated in the meeting. AGC San Diego's contingent of 20 participants was led by 2021 **President Mike Williamson** of *Pacific Coast Iron*, and **Senior Vice President Kari Kyne** of *Kyne Construction, Inc.*

Following comments by both AGC Chapter Presidents, AGC's Legislative Advocate, Felipe Fuentes, provided an overview of the state budget, highlighting the need for more transportation funding. He also reviewed a number of bills moving through the legislative process, including two AGC-sponsored bills, AB 604, and AB 332.

- **AB 604** - Road Maintenance and Rehabilitation Account: accrued interest. Existing law provides for the deposit of various funds, including revenues from certain fuel taxes and vehicle fees into the Road Maintenance and Rehabilitation Account. This bill continuously appropriates interest earnings from revenues deposited in the Account to Caltrans for maintenance of the state highway system or for the State Highway Operation and Protection Program.
- **AB 332** - Hazardous waste: treated wood waste. In the past, treated wood waste (TWW) was handled as non-hazardous material, and contractors could dispose of this material in most landfills. This was due to a state law that authorized the Department of Toxic Substance Control (DTSC) to regulate the handling and disposing of this material. However, the state law that authorized these

regulations sunset in December 2020. Beginning January 1, 2021, TWW is now a fully regulated hazardous waste and must be disposed of, at only Class I landfills. This bill reinstates DTSC's regulations for managing TWW, and they stay in effect until the law is repealed. This is an urgency bill and would take effect immediately.

Eight advocacy breakout sessions followed, and most of the AGC San Diego participants had an opportunity to visit with State Senator Pat Bates and Assembly Republican Leader Marie Waldron. The issue of Skilled and Trained Workforce requirements was addressed in the meeting with Senator Bates, as the requirements have been problematic for both union and non-union contractors. The Senator offered to help legislatively if needed.

The last 20 minutes of the virtual meeting was saved for a well-known political consultant, Rob Stutzman, who provided his take on the Governor's Recall. He was closely involved in Arnold Schwarzenegger's victory in the 2003 recall of Governor Davis, and his comments centered around the differences between 2021 and 2003. With the COVID issues softening, and less voter discontent than in 2003, "things are looking up for the Governor...but anything can happen in California."

All in all, it was a productive, informative, and successful Legislative Day, albeit virtual. Next year, we will be back at it with a trip to the State Capitol. We hope to see you then!

Clarification on Revisions to COVID-19 Emergency Temporary Standard

On Friday, an Alert was sent out detailing the approval of Cal/OSHA's Standards Board revised [May 28, 2021 COVID-19 Emergency Temporary Standard](#). We understand a clarification needs to be made related to face covering requirements when indoors. There are some exceptions to the requirement that all workers, regardless of vaccination status, continue to wear a face covering (see pages 9-10). One particular exception should be highlighted: *A face covering is not required when an employee is alone in a room, or when all persons in a room are fully vaccinated and do not have COVID-19 symptoms.*

The changes will go into effect on or around June 15. We understand that CalOSHA will provide an FAQ in the near future. The [Construction Industry COVID-19 Exposure & Prevention Plan](#) will be revised soon to reflect those changes.

The only thing that can prevent this regulation now is an Executive Order from Governor Newsom.

Briefly, here are the revisions/updates:

Face Coverings:

- **Indoors**, all workers - regardless of vaccination status - will continue to be required to wear a face covering.

- Exception: When an employee is alone in a room, or when all persons in a room are fully vaccinated and do not have COVID-19 symptoms.

- **Outdoors** - regardless of vaccination status - fully vaccinated and unvaccinated workers without symptoms do not need to wear face coverings.

Physical Distancing:

- Employers can eliminate physical distancing and partitions/barriers for employees working indoors if they provide respirators, such as N95s, to unvaccinated employees for voluntary use.
- After July 31, physical distancing and barriers are no longer required indoors (except during outbreaks)
- After July 31, employers must provide all unvaccinated employees with N95s for voluntary use while indoors and in vehicles.

Prevention Program: Employers are still required to maintain a written COVID-19 Prevention Program but there are some key changes to requirements:

- Employers must review the [California Department of Public Health's Interim guidance for Ventilation, Filtration, and Air Quality in Indoor Environments.](#)
- COVID-19 prevention training must now include information on how the vaccine is effective at preventing COVID-19 and protecting against both transmission and serious illness or death.

Exclusion from the Workplace:

- Fully vaccinated workers who do not have COVID-19 symptoms no longer need to be excluded from the workplace after a close contact.

Daily Health Screening:

- No changes were made to the current standard.

Freight Bottlenecks Putting the Brakes on the Economy

The U.S. economy lost over \$42 billion, before the pandemic in 2019, as trucks packed with goods and products got caught in heavily congested roads and bridges across the country. This cost is borne across the entire economy according to data released by the Federal Highway Administration (FHWA). This is a fact that

should also be considered in making regional decisions about transportation as the Federal Government is considering limiting funds for adding road capacity. Here in California, the new Vehicle Miles Travelled (VMT) regulations that have been established via SB 743 will limit road widening projects as far as the eye can see.

Most people don't know that nearly 73 percent of the value of domestic freight is shipped via truck, so road congestion, particularly in urban areas across the country has a large impact on costs. What happens to a truck in Atlanta or Los Angeles affects our costs here in San Diego and vice versa. According to FHWA the value of domestic truck shipments is expected to more than double in the next 20 years. The major corridors across the country are getting more and more congested which means if uncorrected by infrastructure investments the costs to the U.S. economy will grow geometrically.

For example, congestion costs on the Interstate Highway System grew by 25% in the last two years of the FHWA study (2017-2019). Those costs went from \$12 billion in 2017 to over \$15 billion in 2019. If that trend continues, the economic costs from freight bottlenecks will double every eight years. That is unless the states and the Federal Government get serious about infrastructure investments to solve freight bottlenecks all across the country. The national figure of \$42 billion would grow to \$320 billion over the next 25 years.



California, not surprisingly is far and away the king of truck congestion and by a wide margin adds the most costs to the economy due to trucks getting snarled in traffic. In 2019 the total costs due to freight stuck in traffic, in California, was \$6.2 billion and the total delay was 96 million hours. Texas and Florida were a distant second and third with \$ 3.9 billion and \$2.6 billion respectively. No other state was even close. California also has eight of the top 25 most congested freight bottlenecks nationally.

Here are some of the most congested corridors in California and what the costs are annually, which are dominated by Los Angeles and the San Francisco Bay Area:

San Diego has only one section of freeway on the I-805 that breaks into the top 100 of costliest freight bottlenecks across the country. The border is not counted in the FHWA study.

Many of these freight bottlenecks are truly bottlenecks as they are relatively short stretches of freeway. You would think that our policymakers would see the investment potential of investing in infrastructure projects that remove these bottlenecks while getting a significant, and immediate return on investment.

SB 1 has two programs that could be used to help make this state more competitive by reducing truck congestion. Those would be the Congested Corridors Program and the Trade Corridors Enhancement Program. The two together are expected to fund about \$5 billion in projects over the next ten years. It looks like we have some good candidates.

Remember, what happens in L.A. does not stay in L.A. we pay for the truck congestion here in this region as well.

Another Round of Proposed Changes to Emergency Temporary Standards

On Wednesday, June 9, 2021, the Occupational Safety and Health Standards Board decided to withdraw revisions to the Emergency Temporary Standards that were previously sent to the Office of Administrative Law in order to update Cal/OSHA's COVID-19 prevention requirements with the latest guidance. The board posted [new revisions](#) on June 11 that incorporate the latest public health guidance. The revisions will be considered at the board's regular meeting on June 17. In the meantime, the [protections adopted in November of 2020](#) will remain in effect.

Here are the highlights of the proposed revisions from Cal/OSHA on their Emergency Temporary Standard, that will be voted on, and assuredly pass.

- "Respirator" means a respiratory protection device approved by the National Institute for Occupational Safety and Health (NIOSH) to protect the wearer from particulate matter, such as an N95 filtering facepiece respirator.
- Upon request, employers shall provide respirators for voluntary use in compliance with subsection 5144(c)(2) to all employees who are not fully vaccinated and who are working indoors or in vehicles with more than one person.

We will be monitoring the meeting on June 17.

Inflation, Shortages of Materials Creating New Challenges

The construction industry is currently experiencing an unprecedented mix of steeply rising materials prices, snarled supply chains, and staffing difficulties. Competition remains brisk in many infrastructure markets which is keeping some contractors from passing on their added costs. This toxic combination threatens the existence of some firms and will eventually be felt by agencies in their public works project budgets.

Project owners need to recognize how much conditions have changed for projects begun or awarded in the early days of the pandemic, or before, and to consider providing greater flexibility and cost-sharing.

According to a recent national report, contractors are presently facing a threat from fast and steeply rising prices for materials, both for projects that have already been bid or started, and for projects currently bidding. The report outlines that while bids prices from April 2020 - April 2021 have only risen 0.5 %, costs for materials have risen 13%. Contractors who submitted a fixed-price bid in April 2020, based on materials costs at that time, but did not buy the materials until this spring, are getting sticker shock due to the prices for materials. This average increase of 13% can wipe out the profit from a project and create a financial hardship for the contractor.

Additionally, contractors are incurring costs not captured by looking at price indexes. Delayed deliveries, higher expenditures for personal protective equipment and other sanitation measures, and shortages of employees or subcontractors' workers on jobsites due to coronavirus impacts have all driven up contractors' costs. In some cases, project completions are being delayed, which means payments to contractors have also been delayed.

Compounding the problem, many commodities associated with construction are heavily weighted toward materials that have risen much more in price than the overall Producer Price Index (PPI). Some examples of this are:

- The PPI for diesel fuel (at the fuel terminal, not retail) increased 114% between April 2020 and February 2021.
- The PPI for lumber and plywood jumped 62%.
- The index for copper and brass mill shapes climbed 37% and the PPI for steel mill products rose 20%.

Some broad categories of products have not gone up dramatically, but narrower classes of products within those categories have. For instance, the PPI for plastic construction products rose "only" 6% from March 2020 to January 2021. However, suppliers of PVC pipe reported in March that for polyvinyl chloride (PVC) used in utility work, the price from March 2020 to January 2021 had a general increase of 85%. Following extreme winter weather in Texas that knocked out production facilities, now that increase is 270% from March 2020" to March 4, 2021.

Most recently, a leading supplier for utility work reported that prices for the following commodities have jumped dramatically:

PVC Pipe	+66%	In the last 120 days
Ductile Iron Fittings	+51%	In the last 45 days
Ductile Iron Pipe	+ 15%	In the last 45 days

In addition to sudden price increases, contractors are experiencing delivery times that have stretched or become completely unreliable. Some might assume contractors will simply raise their prices to cover the added costs. But the record from previous episodes of escalating materials costs, suggest that the mismatch between materials costs and contractors' prices is likely to persist for an extended period.

The pandemic has caused current production and delivery of many materials to fall short of demand. Initially, a wide range of factories, mills, and fabrication facilities were shut down on their owners' initiative, or because government orders deemed them to not be "essential". Once production facilities were allowed to re-open,



many of them have had trouble getting up to full capacity due to COVID impacts.

Imported products and components also were subject to production and shipping shutdowns in the early months of the pandemic. This particularly affected many products from China and northern Italy. In recent months, production has increased but containers, ships, port space, and trucking capacity have all experienced bottlenecks that have slowed deliveries.

While contractors cannot unclog ports or rescind tariffs, they can provide project owners with timely and credible third-party information about changes, in relevant material costs and supply-chain snarls, that may impact the cost and completion time for a project that is underway, or for which a bid has already been submitted. Owners can authorize appropriate adjustments to design, completion date, and payments to accommodate or work around these impediments.

For projects that have not been awarded or started, owners should start with realistic expectations about current costs and the likelihood of increases. Owners and bidders may want to consider price-adjustment clauses that would protect both parties from unanticipated swings in materials prices. Such contract terms can enable the contractor to build in a smaller contingency to its bid, while providing the owner an opportunity to share in any savings from downward price movements (which are likely at some point, particularly for long-duration projects).

Apprenticeship

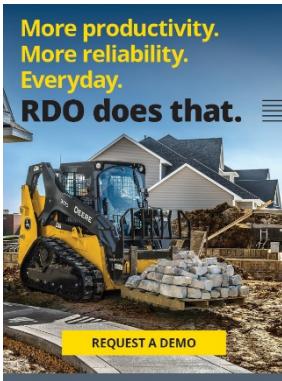

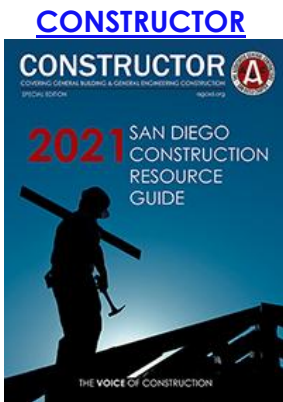
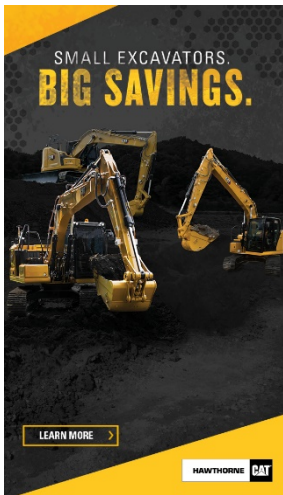

Highway Work Zone Crashes, Still a Major Issue for Contractors

AGC America conducted a national survey of highway contractors and the results are startling. We continue to see an onslaught of errant motorists crashing into highway work

zones, which makes being a highway worker one of the most dangerous occupations in this country. Should our policy makers be doing more?

Sixty percent of highway contractors report that they had at least one or more incidents of motor vehicles crashing into their construction work zones during the past year, according to the [results](#) of the new highway work zone study. But worse yet, almost one-third of highway contractors reported that their firm had five or more incidents of errant motorists crashing through cones and barricades into work zones.

Not surprisingly, this puts everybody at risk and continues to be a serious national problem. In San Diego, we saw two highway workers killed in work zones during the last twelve months, coincidentally both occurred on State Route 94 on Caltrans projects.

The carnage of these work zone incursions is not limited to the workers in the work zone, but also impact the drivers and their passengers involved in these crashes. Thirteen percent of the incidents resulted in fatalities for drivers and passengers, while 4% of the incidents resulted in fatalities



of workers on the scene. According to the survey a vast majority of contractors believe that highway work zone crashes are more of a risk now than a

decade ago. When asked why, there was a strong majority of responses that cited three central causes for the increased danger. They were increased volume of traffic, drivers distracted by talking and texting on cell phones, and motorists simply driving too fast for the conditions.

What measures would help reduce injuries and fatalities in work zones? According to contractors, the top four would be:

- Greater police presence at work zones where there is a lane closure
- Stricter enforcement of existing laws regarding work zone moving violations
- Stricter laws against cell phone usage
- Closing roads and detouring traffic

We call on public agencies who have work on high-speed highways and arterials to take pro-active steps to improve work zone safety. Particularly where the work requires lanes to be closed and workers are working on foot with no protection from speeding public traffic.

Caltrans for example, has done this in recent years and is a model for other agencies to follow. First, they have been holding annual safety summits, partnering with law enforcement. They have enacted 55 mph speed zones through their construction projects which allows for stricter enforcement of speeding. Some new technology is now becoming common such as the automated flagger system which allows flaggers in one way traffic control scenarios to stand out of harm's way and safely shepherd traffic through two lane road construction sites. The game changer for worker safety is that Caltrans is willing to issue contract change orders in certain situations to compensate contractors to provide positive barriers/barrier vehicles to protect vulnerable workers on foot near high-speed traffic.

California should take a look at what is happening in other states. Drivers in Illinois who injure roadside workers or fail to obey construction zone signals now face the possibility of enhanced fines, and even jail time. Known as Scott's Law, it was named after Lt. Scott Gillen of the Chicago Fire Department, who was struck and killed by an intoxicated driver while assisting at a crash scene.

The law increases the minimum fine to \$250 for a first violation of Scott's Law, and to \$750 for a second violation. It also adds a \$250 fee for any violation, with that money going into a new fund to pay for driver education materials. In addition, the new law allows drivers to be charged with a Class A misdemeanor, punishable by up to a year in jail, if the violation results in damage to another vehicle. For cases in which the violation results in the injury or death of another person, drivers can be charged with a Class 4 felony, punishable by one to three years in prison.

Public officials need to take steps to better protect highway work zones, by boosting police presence and enacting tougher laws and penalties for drivers, speeding and or using their cell phones. But ultimately it is the motorists who must be careful when passing through highway work zones. The best thing anyone can do to protect themselves and workers is to **slow down, put the phone away, and pay attention** when they are in a highway work zone.

On Thursday, a gaggle of 20 or so Senators from both parties joined President Biden in announcing a deal on the much anticipated infrastructure bill. As our astute readers know, Biden proposed an audacious and perhaps ambitious \$2.3 trillion (yes, with a T!) dollar infrastructure bill earlier this year. The so-called American Jobs Plan included roughly \$115 billion for bridges, highways, and roads.

For months, House and Senate leaders have disagreed on two major points: how much to spend and how to fund it. So, what's in the compromise? For now, it's a \$579 billion framework that would ultimately include \$973 billion in new and baseline dollars over five years or \$1.2 trillion over eight years. The details can be found [here](#), but essentially it's \$312 billion for "transportation" infrastructure like roads, bridges, and transit and another \$266 billion for "other" infrastructure like water and broadband.

How did we get here? Democratic Senator Kyrsten Sinema (AZ) joked, "Wine. The answer was wine. There was plenty." She and fellow Senator Mark Warner (D-VA) evidently sponsored libations and pizza. So, apparently the key to working out a trillion-dollar

compromise in D.C. is the same as getting your friends to help you move in college. Good to know.

Where did the other \$1.3 trillion dollars in (non-infrastructure) spending promised by Biden in his initial package go? It appears headed to the same place as the rest of the progressive wish list: a massive budget reconciliation plan. Senate Majority Leader Schumer and Speaker Pelosi have all but promised that as a way to keep their respective caucuses together, while delivering the White House a "win" on one of the President's campaign promises.

What is less clear is where the Protecting the Right to Organize (PRO) Act stands with regard to this compromise. The labor friendly bill passed the House back in March, but has been stalled in the Senate. Schumer has said he would bring it to the Senate floor once he had 50 co-sponsors. There were 44 when it was initially introduced, and Senators Manchin (D-WV) and King (I-ME) joined a few months ago. Interestingly, two of the three Democratic Senators who have not co-sponsored, Sens. Sinema and Warner, are part of this latest bipartisan group of negotiators. While the PRO Act was included in the American Jobs Plan, there has been no mention of it in this compromise and because it is not a funding stream, it cannot be included in the budget reconciliation.

This weekend's political jousting shows just how slim the margins in D.C. are. In 48 hours, we had a veto threat from the White House, outrage from both parties over what is or is not in the bill, a deliberate de-linking of the infrastructure bill from other spending proposals (see previous comment about the wish list), and finally the President walking back his veto threat. If you're keeping score at home, it appears that we had a lot of talk to end up essentially where we were on Friday. As the old saying goes, if pro is the opposite of con, then what is the opposite of progress? Clearly, we have a long way to go, but it's a start. And, even if for a brief moment, the word "compromise" was used in D.C. without the word "no" in front of it. In the meantime, there's always wine...*plenty!*

Pure Water in East County

The AGC contractors who build, maintain, and replace our water and wastewater infrastructure have been busy in recent years as water districts and municipalities have focused on these critical pieces of the infrastructure. More and more the collection of wastewater and



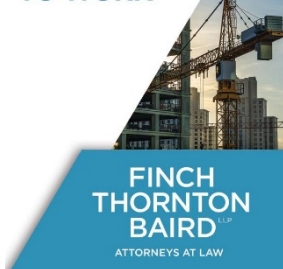

the production of water supply have been combined in the drought prone southwest.

A wastewater recycling project in East County is set to receive a large infusion of federal funds to build new water producing infrastructure. The U.S. Environmental Protection Agency has recently awarded a \$388 million low-interest loan to help finance the East County Advanced Water Purification (AWP) Program. The Program is a partnership between San Diego County, El Cajon, Helix Water District, and Padre Dam Municipal Water District who have joined together in a Joint Powers Authority.

The East County Advanced Water Purification Joint Powers Authority (JPA) was established in November 2019 under state law and a Joint Exercise of Powers Agreement. The main purposes of the Agreement were to:

- Design, construct, operate, and maintain the East County AWP Project
- Receive, convey, treat and dispose of wastewater
- Produce and deliver drinking water




The project is estimated to cost \$640 million and create about 2500 local jobs. When completed it is expected to provide up to 30 percent of East County's drinking water supply for Santee, La Mesa, El Cajon, Spring Valley, Lakeside, and Alpine.

The EPA loan was one of 51 federal loans doled out by the EPA under the Infrastructure Finance and Innovation Act. The agency approved a total of \$21 billion in projects across the country.

The East County facilities are planned to come online in 2025 and are expected to produce 11.5 million gallons a day of purified wastewater. This recycling effort will use a reverse osmosis purification process. Then mix this product with water in Lake Jennings before piping water from Lake Jennings to be treated further at a Helix Water District Facility.


The East County AWP Project consists of three packages. Project construction is expected to begin in 2022 and run through 2025.

Package 1
Includes: a 16 Million Gallons Daily (MGD) Water Recycling Facility, an 11.5 MGD Advanced Water Purification Facility, a solids handling facility, a product water pump station and a new visitor's center.

Package 2
Includes designing and constructing a 10-mile Advanced Water Purification pipeline, a dichlorination facility and inlet to Lake Jennings.

Package 3
Includes retrofits and capacity expansions of the Influent Pump Station and East Mission Gorge Pump Station, as well as the installation of a 3.5-mile-long force main, a 3-mile-long residuals bypass pipeline and a 1.7 million gallon a day lift station for the residuals bypass system.

The water recycling program is aimed at buffering the region from future droughts and reducing discharges of partially treated wastewater into the Pacific Ocean. While the project's cost could increase rates in the short term, JPA officials believe the investment will pay off in coming years as climate change is expected to dramatically impact supplies of imported water from the Sierra Nevada and Colorado River.

The San Diego Region is rapidly building water producing infrastructure that may eventually result in much more water independence. The City of San Diego has started construction on the first of three phases of the San Diego Pure Water Project. The first phase of which is a \$1.5 billion set of projects. The Poseidon desalination plant has been up and running and producing drinking water for several years in Carlsbad. Like the East County AWP, the Pure Water Oceanside project also received a low-cost EPA loan and when completed will supply 30 percent of the City's drinking water.




