Bye George

On November 28, the House of Representatives returned to full strength...and 3 days later on December 1, it was back to 434. In a historic vote Friday, 311 members of the House voted to expel one of their own, embattled former **Rep. George Santos**. Santos became just the sixth member of the House to be expelled in history. He was the first Republican. [According to CBS News](#), three members were expelled in 1861 for “disloyalty to the Union” as they served in the Confederate Army. More recently, Michael Myers was expelled in 1980 for his role in the Abscam sting, and in 2002, when I was a young Hill staffer, James Traficant was expelled 420-1. Traficant was a colorful member (to say the least) who famously ended each floor speech with “beam me up” and even tried to win his seat back from prison!

Santos has been a thorn in the side of the institution and especially Republicans since his surprise election last year, but with a razor-thin margin, some had speculated Republicans would not be anxious to get rid of him. Several lawmakers suggested due process and cited the voters’ responsibility for electing and subsequently un-electing members. But, a scathing House Ethics Committee report before Thanksgiving left the majority of the House feeling there was no choice. Just one month prior, on November 1, an expulsion resolution failed. By law, such a resolution requires a 2/3 vote, which is a high threshold, especially in modern times. With 311 votes, it cleared that benchmark relatively easily. While the expulsion officially removed the congressman from office, it does not carry any additional baggage, nor does it preclude him from running for office in the future – although the slew of federal indictments may take care of the latter.

So, what does it mean? Well, for starters the majority is now down to 8. We’ve seen how this small margin has wreaked havoc on selecting a Speaker twice in the last year. Additionally, it appears to have emboldened some of the more vocal members who have now taken down a Speaker of the House and booted one of their own with relative ease. Next up? It now seems more likely than ever that impeachment will be on the table next year, not just for the President, but for his Cabinet as well, as tensions continue to rise. And, what about **Senator Bob Menendez** who is facing his own federal indictment? Will his colleagues throw him out? Will the feds get to him before the voters?

2024 is a presidential election that may very well be a rematch of 2020 and the House and Senate are also both very much up for grabs. If the events of 2023 are any indication, buckle up...it's going to be a bumpy ride.

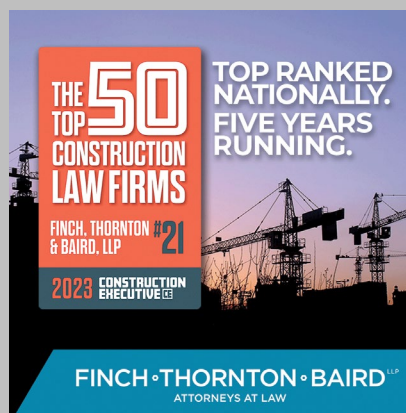

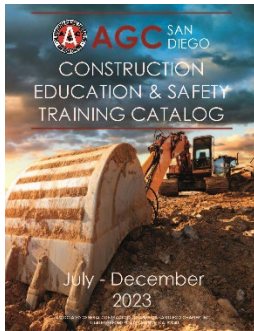

Fed, State, Local Round-up

It's been an interesting year for **Kevin McCarthy**. In January, after 15 rounds of voting, he got the prize some would say he'd been seeking his entire life – the Speaker's Gavel. Nine months later, he was ousted from the post and two months after that he resigned from Congress. It's been a rapid descent for the once-rising star of the Republican Party. For his part, McCarthy has vowed to stay in the fight, and party leaders are hopeful he does – his fundraising prowess especially in his home state has been second to none over the past decade, although donors generally prefer to give to power brokers, not former members with "retired" after their names. His departure also sets off a scramble to fill his deeply red seat, which has not been truly *open* since before his predecessor and former boss, **Bill Thomas**, first ran for the seat in 1978! Current Assemblymember and former McCarthy aide, **Vince Fong**, announced last week that he will forgo the chance to run for the seat and seek re-election to the Assembly. **State Senator Shannon Grove** is widely expected to throw her hat in the ring and would likely enter the race as the front-runner.

Speaking of former Reps, expelled Congressman **George Santos** reportedly made more money selling Cameo appearances in the 48 hours after being booted by his colleagues than he made in the year he served in the House. Santos is now commanding \$500 per virtual appearance and calls himself a "[former congressional icon](#)" on the site.

The State of California, which has for years operated under a surplus, is now facing a massive deficit. According to *Politico*, "The latest deficit figure — calculated by the nonpartisan Legislative Analyst's Office and released Thursday — far exceeds the \$14.3 billion estimate from June. The shortfall, which is the highest in dollar terms but not as a percentage of overall spending, threatens to upend the upcoming legislative year by forcing Gov. Gavin Newsom and lawmakers to make spending cuts on a scale few term-limited elected officials in Sacramento have faced." This will be especially challenging as lawmakers take their cases to the voters in 2024 and **Governor Newsom** ramps up his

In San Diego, former Councilman-turned-radio-host-turned-sometimes-candidate, **Carl DeMaio** has announced his candidacy for the 75th Assembly District. The seat currently held by **Assemblymember Marie Waldron**, is solidly Republican, but also features several candidates who have been running for months. DeMaio pulled papers and made his announcement two days before the filing deadline for the March primary. DeMaio claims \$600,000 already raised for the race and enters with significant name ID. AGC San Diego has endorsed **Andrew Hayes** for the seat. Hayes is currently a Lakeside Union School Board Member and serves as District Director for **State Senator Brian Jones**.

Lastly, rumor has it the long-anticipated **Metropolitan Transit Systems (MTS)** Project Labor Agreement (PLA) is on the docket for **Thursday**. While the agenda has not officially been posted, we have it on good authority that it will be on there. To make your voice heard, please see the instructions at the link below. MTS allows written communication before the meeting, or you can attend in person, call in, or participate via Zoom. The meeting begins at **9 am**. 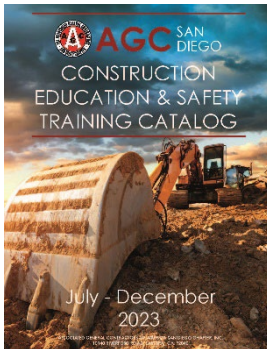

The AGC Meetings & Events Committee and the AGC Build & Serve Committee collected toys for Christmas, and it was one of the largest collections ever!

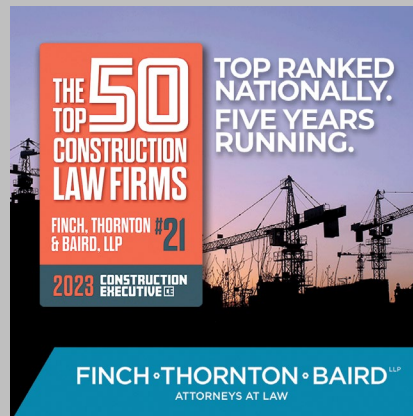

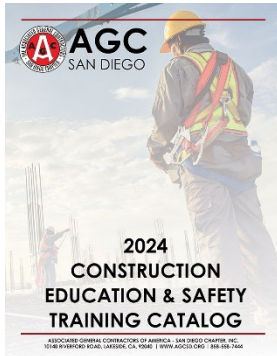
