## Stormwater Compliance Training

### QSP / QSD TRAINING

Are you interested in developing and implementing Stormwater Pollution Prevention Plans (SWPPPs) on your own? AGC and Golden State Stormwater Trainers provides comprehensive State Water Resources Control Board-approved training courses to provide you with the skills you need to become a stormwater management professional.

In order to become a Qualified SWPPP Practitioner (QSP) or Qualified SWPPP Developer (QSD), candidates are required to take a California Stormwater Quality Association-approved training course from a qualified Trainer of Record (ToR). Course work is organized into eight separate content modules. Modules 1-5, covered during the 1st and 2nd days of the training, are required for both QSP and QSD certifications. Modules 6-8 are covered during the 3rd day of training and are only required for individuals seeking QSD certification.

In order to acquire the QSP certification, the candidate must be one of the following:

A Certified Erosion, Sediment and Storm Water Inspector (CESSWI) registered through EnviroCert International, Inc. A Certified Inspector of Sediment and Erosion Control (CISEC) registered through Certified Inspector of Sediment and Erosion Control, Inc.

A Qualified SWPPP Developer with one of the prerequisite professional registrations or certifications. You must also attend a State Water Board-sponsored or approved QSP training course like ours and pass an examination administered by the State Water Board.

### QUALIFIED STORMWATER DEVELOPER (QSD) / 3 DAYS

You must also hold one of the following Certifications:

- A California registered professional civil engineer;
- A California registered professional geologist or engineering geologist;
- A California registered landscape architect;
- A professional hydrologist registered through the American Institute of Hydrology;
- A Certified Professional in Erosion & Sediment Control (CPESC) registered through CPESC Inc.;
- A Certified Professional in Storm Water Quality (CPSWQ) registered through CPSWQ Inc.; or a professional in erosion and sediment control registered through the National Institute for
- Certification in Engineering Technologies (NICET)

In addition to the registrations or certifications and appropriate experience as required, you must also attend a State Water Board-sponsored or approved QSD training course within two years of the adoption of the CGP (September 2, 2011), and have taken and passed an examination administered by the State Water Board.
